## **December 2021: SOFA-defined Severe Injuries (SIs)**

December 2021 is the latest month available for SIs as defined (see definition at bottom of page) by SOFA in its report, *Severe Injuries to Train and Engine Service Employees: Data Description and Injury Characteristics* (July 2001). Feel free to cite, circulate, transmit, reformat, and reference this information.

**SIs in December 2021:** There were 6 SIs in December 2021. One was an amputation to the arm or hand. The other 5 SIs were fractures: 3 to the leg or foot; 1 to various body parts of equal severity; and 1 to the head or face.

**Comments:** There was a slight increase in SIs in year 2021 compared to 2020 (56 vs. 53). Amputations, which are included in SI totals, declined slightly (7 vs. 9). Historically, there is an overall downward trend in SIs, although year-to-year counts increase at times. Since 2009, SIs have occurred within a range of a high of 76 per-year, and a low of 47 per-year.
