Further to the message below, this is to advise you that the following requirements under the *Transportation of Dangerous Goods by Rail Security Regulations* for railway loaders are now required to be in place:

- Development and implementation of a security plan;
- Development of security plan training; and
- Security awareness training.

This message is further to our email of March 20, 2020.

Given the ongoing COVID-19 pandemic and the impact it may be having on your ability to work towards the implementation of the *Transportation of Dangerous Goods by Rail Security Regulations* (Regulations), **an additional extension is being granted** to allow you more time to meet the regulatory requirements applicable to your operations.

For all railway loaders, an extension to all regulatory requirements applicable to your operations has been granted to **August 3, 2020**.

For railway loaders required to implement a security plan under section 10 of the Regulations, we will be providing information on how to submit your security plan electronically through a Transport Canada secure portal in the coming months.

We would like to thank you for your continued collaboration as we move forward with the implementation of the Regulations. Please ensure this message is forwarded to your members and others that may be impacted by these Regulations. Should you wish to be removed from this distribution list, please let us know.
